Contract For Service



Terms and Conditions

All material must be within the container and cannot exceed the top of the container. Fill in a manner that ensures even distribution of weight. An additional service charge will be applied to all loads over the agreed tonnage and under no circumstances shall the weight exceed 11 tons. If in excess of 11 tons, a surcharge, or 'excessive weight charge' will result in addition to the agreed terms. In addition to contracted tonnage CWS calculates overages to the next whole ton. CWS reserves the right to refuse to haul any container which exceeds capacity. Customer agrees to provide clear access to the container for the purpose of loading and unloading. If CWS is unable to perform service for aforementioned reasons, or a driver is required to wait in excess of 20 minutes, an idle charge of \$125 will result. CWS will not accept: appliances, tires, barrels, stumps, paint, flammable materials or toxic waste as directed by local, county, state or federal regulations. Customer assumes responsibility, financial or otherwise, for any and all materials deposited in the containers. 10-yard 'low boys' are designed for inert materials only: rock, concrete, bricks, and clean dirt (FREE of grass and roots). The presence of other materials including trash, wood, glass, plastic, metal constitutes a 'contaminated load', unless the lowboy was designated for non-inert material. CWS will assess a contamination charge of \$75 to \$150, depending upon the severity of the contamination. CWS is not responsible for damages that may occur to customer's property when providing service as directed by a customer or their agents. If a container is damaged by the customer, their agents, or third parties while in the customer's care, customer agrees to pay reasonable repairs to the container. If collection action is required, customer agrees to pay all collection costs including attorney's fees. I acknowledge receipt of service and agree to comply with the above terms and conditions.
